# What were some of the challenges you faced before using CertiCraft?

There was so much manual labour and time lost. We started off trying to keep track of all the information on spread-sheets, but it was tedious. We thought it would be a good idea to get software, so we tried one of your competitors, but it was confusing. We couldn't understand where the inventory was. People on the floor stopped using it because it took too long. "I'll enter the data later", they would say. Some things would get missed, and the numbers weren't current. So we switched back to spreadsheets, but everything took a long time and there was way too much room for human error. Bits of info wouldn't get entered, or a wrong number would get in there... as a result, we wasted days trying to find where the discrepancies were, and we couldn't trust the numbers.



### How has CertiCraft helped you so far?

Generating reports for Health Canada and the CRA is amazing. What previously took 4-6 hours of crunching numbers suddenly took 5 minutes. But it was more than just the number crunching—every time the numbers didn't match, we would have to go and find it. Recounts, trying to find bits of paper with missing data, getting multiple staff involved in these investigations to find where the plants went... CertiCraft found errors immediately, and saved a lot of headache trying to figure it out ourselves. If all the work was done and at the end we found it was off, we had to do it all over again, resulting in a week of wasted time. Sometimes we would get the numbers right, but then CRA looks at it and what we did didn't make sense to them. With CertiCraft, it's already in the format they want and understand.

After 6 months of seeing every demo out there, CertiCraft was the easiest. We understood the flow immediately. It was simple to understand, organized, and everyone could catch on without tons of explanations.
